

LATIMER COUNTY BOARD OF COUNTY COMMISSIONERS
MINUTES FOR MONDAY, MAY 22, 2023

The Latimer County Board of County Commissioners met on May 22, 2023 at 9:00 a.m. at the Commissioner's Office located in the Latimer County Courthouse, 109 N. Central, Wilburton, Oklahoma. Members present were: Jeremy Bullard, Jerry Jiles and Rodger Kimble. Leigh Ivanoff, 1st Deputy Latimer County Clerk's office took the minutes.

Jeremy Bullard, Chairman, called the meeting to order.
