

**LATIMER COUNTY BOARD OF COUNTY COMMISSIONERS
MINUTES FOR TUESDAY, OCTOBER 10, 2023**

The Latimer County Board of County Commissioners met on October 10, 2023 at 9:00 a.m. at the Commissioner's Office located in the Latimer County Courthouse, 109 N. Central, Wilburton, Oklahoma. Members present were: Jeremy Bullard, Jerry Jiles and Rodger Kimble. Guests were Cody Woods, Wade Hoyt Thomson, Jana Scott, Luke Underwood, Adam Woodruff, Melinda Brinlee, Delana Moon, and Darrell Brinkley. Erin Adams, Latimer County Clerk, took the minutes.

Jeremy Bullard, Chairman, called the meeting to order.

Rodger Kimble made a motion to approve and sign the minutes from 10/02/2023. Jerry Jiles seconded the motion. The motion was voted as follows: Bullard-aye; Jiles-aye; Kimble-aye. The motion carried.

Jerry Jiles made a motion to approve and sign the miscellaneous appropriations. Rodger Kimble seconded the motion. The motion was voted as follows: Jiles-aye; Kimble-aye; Bullard-aye. The motion carried.

Jerry Jiles made a motion to approve the monthly reports for the Assessor, County Clerk, Election Board, Treasurer for September 2023. Rodger Kimble seconded the motion. The motion was voted as follows: Kimble-aye; Bullard-aye; Jiles-aye. The motion carried.

Jerry Jiles made a motion to approve the monthly report for the Assessor for August 2023. Rodger Kimble seconded the motion. The motion was voted as follows: Bullard-aye; Jiles-aye; Kimble-aye. The motion carried.

Jerry Jiles made a motion to table further discussion and possible action on the construction plans for JP#29945(04), Bridge and approaches along Rolling Hills Road over Jackson Creek, near Talihina, OK., Latimer County, within District #2. Rodger Kimble seconded the motion. The motion was voted as follows: Jiles-aye; Kimble-aye; Bullard-aye. The motion carried.

Rodger Kimble made a motion to approve the letter of assistance from the Town of Red Oak, requesting a load of sand; within District #3. Jerry Jiles seconded the motion. The motion was voted as follows: Kimble-aye; Bullard-aye; Jiles-aye. The motion carried.



The Board discussed the transferring of the hospital tax millage of .26 to the county general budget. No action was taken.

The Board discussed the amended budget recommendation from Mike Kern, Budget Maker to the Latimer County Excise Board for the Latimer County Budget FY 2023-2024. No action was taken.

Darrell Brinkley discussed the status of the decision of the Commissioners regarding the old WPA Road closure. The Board stated that the road was still closed from 2006 and that the matter was in a civil case as advised by the District Attorney's office.
