

LATIMER COUNTY BOARD OF COUNTY COMMISSIONERS
MINUTES FOR JANUARY 20, 2026

The Latimer County Commissioners met in a regular meeting on Monday, January 20, 2026 at 9:00 a.m. at the Latimer County Courthouse located at 109 N. Central, Wilburton, OK. Members present were Jeremy Bullard, Jaden Petty, and Rodger Kimble. Guests were: Nathan Montgomery, Wade Hoyt Thomson, Adam Woodruff, Chris Church, Melinda Brinlee and Mark Showell. Erin Adams, Latimer County Clerk took the minutes.

Jaden Petty, Chairman, called the meeting to order.




