The Board reviewed the Manager's Report.

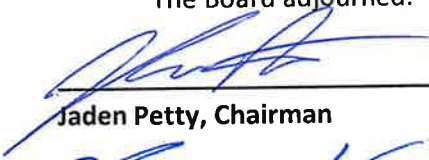
The Board reviewed the Secretary's Report.
