
The Board discussed the letter regarding the inventory Audit Report from the Oklahoma State Auditor's Office.


Under old business:



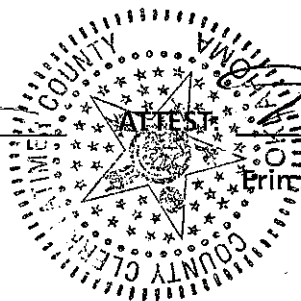
