

LATIMER COUNTY BOARD OF COUNTY COMMISSIONERS

MINUTES FOR JANUARY 12, 2026

The Latimer County Commissioners met in a regular meeting on Monday, January 12, 2026 at 9:00 a.m. at the Latimer County Courthouse located at 109 N. Central, Wilburton, OK. Members present were Jeremy Bullard, Jaden Petty, and Rodger Kimble. Jaden Petty Chairman, called the meeting to order.


Under old business:




