MINUTES FOR MONDAY, JANUARY 6, 2025

The Latimer County Board of County Commissioners met on January 6, 2025 at 9:00 a.m. at the Commissioner's Office located in the Latimer County Courthouse, 109 N. Central, Wilburton, Oklahoma. 


