

**LATIMER COUNTY SOLID WASTE TRUST AUTHORITY
MEETING MINUTES FOR MONDAY, JANUARY 12, 2026**

The Latimer County Solid Waste Trust Authority met on January 12, 2026 at 12:00 p.m. Meeting was held at the Latimer County Courthouse/Commissioners Office, located at 109 N. Central, Wilburton, OK. 
The Board discussed the employment status of the Latimer County Solid Waste Manager. No action was taken.


Under new business:




