The Board discussed the Resolution No. 2025-34 for the Buffalo Valley Volunteer Fire Department regarding their volunteer status. No action was taken.

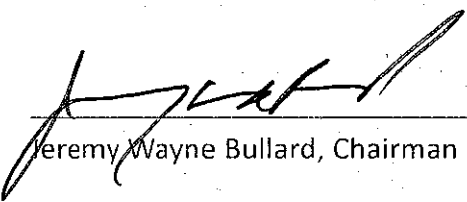
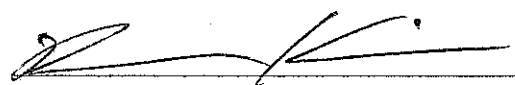
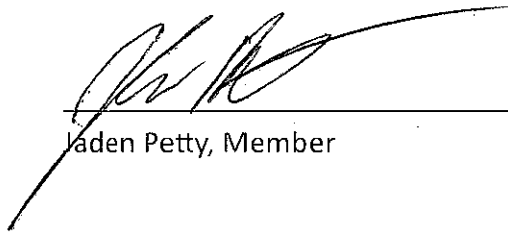

The Board discussed the Resolution No. 2025-35 providing rules and regulations for the Buffalo Valley Volunteer Fire Department. No action was taken.
