MINUTES FOR JULY 21, 2025

The Latimer County Commissioners met in a regular meeting on Monday, July 21, 2025 at 9:00 a.m. at the Latimer County Courthouse located at 109 N. Central, Wilburton, OK.



The Board and Elected Officials discussed the Budget for Latimer County for FY 2025-2026 with Mike Kern, Budget Maker. No action was taken.


At 11:00 a.m., the Board opened and discussed the 6-month bid for screened native rock.

No new business was discussed.



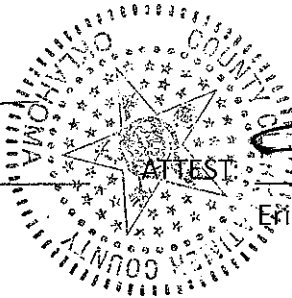
