Under new business:


The Opioid Abatement Grant was discussed by the Commissioners.



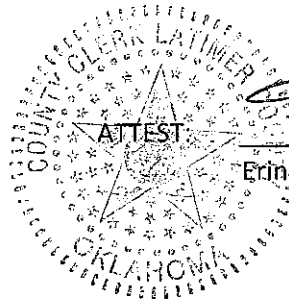
