PETITION

COME NOW THE PETITIONER, Buffalo Valley Vol. Fire Dept., whose representative is Regina Kennedy, and respectfully represents and shows to the honorable Board of County Commissioners of Latimer County as follows:

1. The petitioner herewith petitions the Board of County Commissioners of Latimer County, Oklahoma for their order organizing the Buffalo Valley Vol. Fire Department, a county fire department to be organized pursuant to the provisions of Subsection D of 19 O.S. §351.
2. The petitioner is a corporate fire department organized pursuant to 18 O.S. §592, has a Public Protection Classification of Nine (9) or better from the ISO Commercial Risk Services, Inc, and does not have less than six or more than twenty members per fire station.
3. The proposed boundaries of the county fire department are attached to this petition and appear in Exhibit 1.
4. Attached to this petition and identified, as Exhibit 2 is a map of the proposed county fire department, which is drawn to a scale of one (1) inch to the mile.
5. The proposed county fire department shall have administration and control of all fire department real and tangible assets.
6. The petitioner shall retain ownership of all existing fire department assets. The petitioner shall retain administration and control over all existing intangible assets such as cash and marketable securities. The petitioner shall hold ownership of all future acquired assets if said assets are paid from funds raised by petitioner.
7. It is the recommendation of the petitioner that the Board of County Commissioners appoint the five individuals shown on the attached Exhibit 3 as members of the Board of Directors of the proposed county fire department.
8. The original of this petition has been filed with the County Clerk of Latimer County, Oklahoma this 4th Day of August, 2025

NOW WHEREFORE, the petitioner prays that upon the presentation of this Petition, that the Board of County Commissioners of Latimer County, Oklahoma direct the County Clerk to give notice of such public hearing as prescribed by law, and that the Board of County Commissioners determine that if such conversion of the corporate fire department to a county fire department will be conducive to the public safety of the affected area herein, then said board shall authorize and approve the organization of said county fire department.

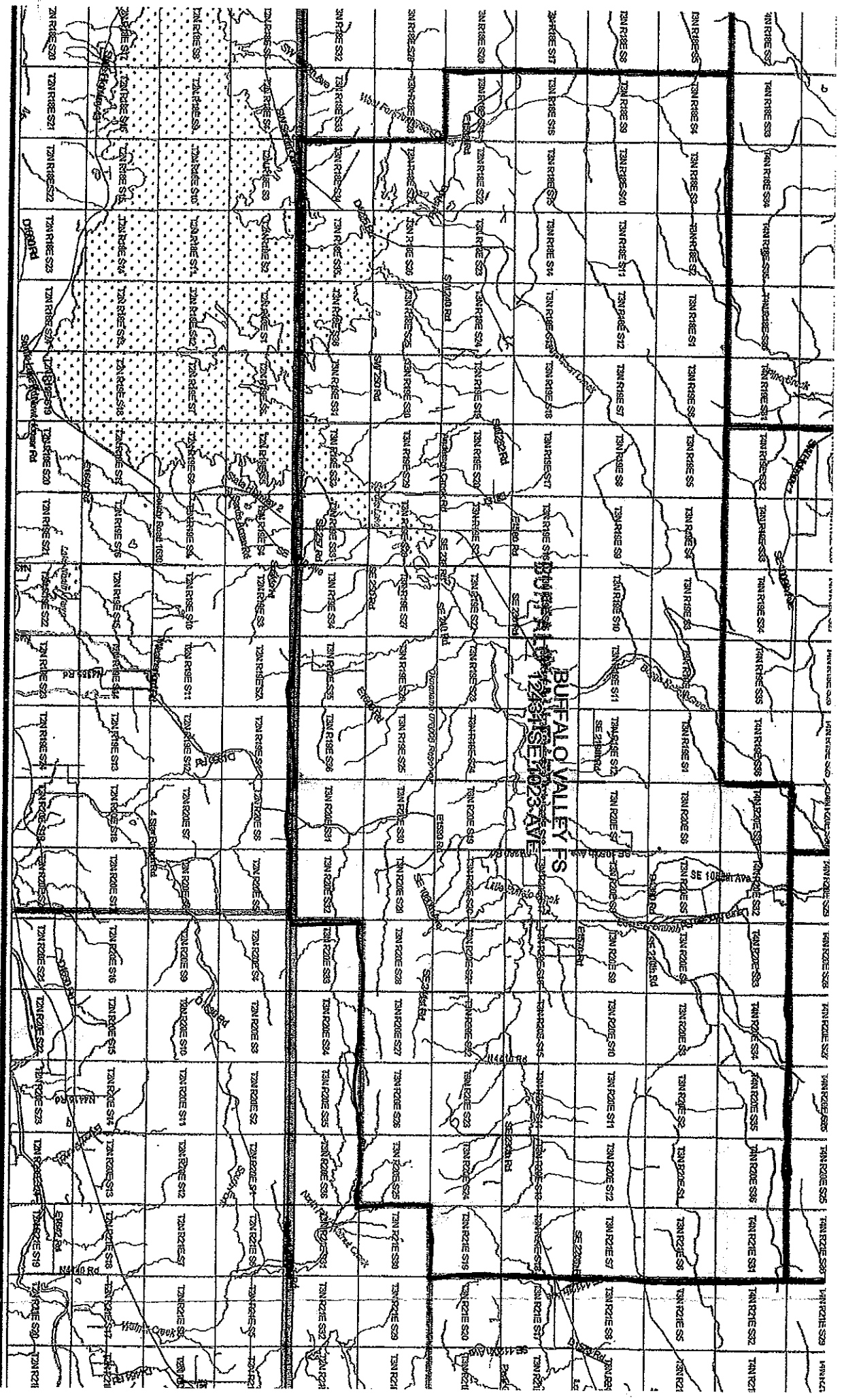
